General Terms & Conditions:

- 2) Scope of Work-As per Annexure-B.
- 3) Taxes and Duties-The rates are accepted inclusive of all taxes and duties.
- **4.)** Work Completion Period: Work should be completed successfully within 30 days from the date of issue of order.

- **5.)** Security Deposit- You will have to pay security deposit amounting to 5% of the ordered value within 7 (Seven) days from date of receipt of work order otherwise it will be deducted from your first bill. The same will be refunded to you on satisfactory execution of order. No interest will be paid on this Security Deposit while refunding Security Deposit. In the event of unsatisfactory performance of the contract or non-compliance to T&C, Scope of Works this amount will be forfeited.
- **6.)** Terms of payments: You should submit your Bills in triplicate after successful execution of the work order along with Work Completion Certificate duly certified by SLDC IT Engineer and payment will be made within 30 days, subject to availability of the funds. No advance payment will be made.

- 8) All the expenses towards visit of maintenance person & maintenance cost shall be borne by the Contractor.

ANNEXURE 'B'

Scope of Work

Scope of works includes but not limited to the following tentative works

- 1. Supply, Installation, commissioning and configuration of the equipment mentioned in Annexure-A as per the requirement of MSETCL.
- 2. Equipment furnished shall be complete in every respect with all mountings, fittings, fixtures and standard accessories normally provided with such equipment's and/or needed for erection, completion and safe operation of the equipment's as required by applicable codes though they may not have been specifically detailed in the tender document, unless included in the list of exclusions. All similar standard components/parts of similar standard equipment's provided shall be interchangeable with one another.
- 3. The Bidder shall be responsible for providing all materials, equipment's, and services, specified or otherwise, which are required to fulfill the intent of ensuring operability, maintainability, and reliability of the complete equipment covered under this specification within his quoted price. This work shall be in compliance with all applicable standards, statutory regulations and safety requirements in force of the date of award of this contract.
- 4. The bidder shall also be responsible for deputing qualified personnel for installation, testing, commissioning and other services under his scope of work. All required tools and tackles for completing the scope of work as per the specification is also the responsibility of the bidder.
- 5. The installation of equipment shall be accepted only after installation tests are over. Integration test needs to be done by the bidder, wherein video conferencing demonstration needs to be done between 2-3 locations using MPLS/Internet links.
- 6. Monitors for this Video Conferencing system will be provided by the MSLDC Office.
- 7. Scope of Work shall also include
 - a. Powering on equipment after ensuring correctness of terminations interfaces and power supply and making the system ready for testing and commissioning.
 - b. Configuration of the equipment as per the requirements of MSETCL.
 - c. Assistance for familiarization and operation of the installed system & services for One Year after acceptance of system.
 - d. Onsite warranty for all Installation and Hardware delivered for minimum one year and extended as per OEM guarantee/warranty offered.

ANNEXURE 'C'

TERMS and CONDITIONS:

- 1. Work Completion Period: Work should be completed successfully within 30 days from the date of issue of order.
- 2. **Penalty for Late Delivery**: if the contractor fails to complete the work within stipulated period as above, penalty towards delay @ ½ % per week maximum extent of 10% of order value will be levied and deducted from bill for non-execution of work.
- 3. **Penalty for downtime:** Agency/Company should solve the problem within two working days from the time of issue reported. If this downtime exceeds more than two working days then Rs. 100/- per day maximum extent of 10% of order value will be charged as penalty.
- **4.** Payment: You should submit your Bills in triplicate after successful execution of the work order along with Work Completion Certificate duly certified by SLDC IT Engineer and payment will be made within 30 days, subject to availability of the funds. No advance payment will be made.
- 5. Security Deposit: You will have to pay security deposit amounting to 5% of the ordered value, otherwise it will be deducted from your first bill. The same will be refunded to you ONE YEARS after satisfactory execution of the order. In the event of unsatisfactory performance of the contract or non-compliance to T&C this amount will be forfeited.
- 6. No extra charges for transportation, T&P, labour, material etc. will be paid, it will be arranged by you only.
- 7. When the configuration/ feature required is not available in a particular model, next available higher configuration model shall be offered

8. Consignee for supply

- 9. <u>Support Period:</u> You will provide services for any technical problem in the executed work for the period of ONE YEAR in coordination with OEM.
- 10. If any dispute arises, the decision of the undersigned is final and binding on you.
- 11. The undersigned reserves the right to cancel any or all the quotations without assigning any reason thereof.
- 12. If any loss occurs to MSLDC property during execution of works, you should make it at good at your cost.
- 13. Income tax/WCT will be deducted as per rules.

- 14. No increase, decrease, discount reduction or any other changes in the price will be acceptable after the opening of the quotation.
- 15. Partial supply/installation/commissioning will not be accepted by the MSETCL. No any payment will be made for partially executed work.
- 16. Any variation in the rates, etc. will not be allowed on any ground such as mistake, misunderstanding, typographic etc. after the bid has been submitted.
- 17. During the period of contract, no upward revision of charges will be accepted.
- 18. In case of dispute, if any, the legal jurisdiction of the court shall be Mumbai only.
- 19. Apart from the above points, all the terms and conditions published by MSETCL in booklet "Tender & Contract of Works" are applicable here also.
- 20. General Conditions: Bidder will be deemed to be fully aware of the MSETCL's General conditions of contract for the supply of plant, equipment and material particularly in respect of security deposits, terms of payment penalty for late delivery etc. Any ignorance of these conditions will not exempt you from your liability to abide by the same. General conditions are applicable as per MSETCL Rules and regulations. Moreover, the right to reject any or all tenders in part or full without assigning any reason is reserved by the undersigned. Also the undersigned reserve the right to alter/amend /cancel any or all the terms and conditions stipulated above at any time in the interest of company without assigning any reasons thereof
- 21. Signing Of Contract Agreement: In case order is placed, you will have to enter an agreement with MSLDC, MSETCL, in the prescribed format on bond paper of Rs. 500/amount (Amendment vide Maharashtra Stamp Act, 20 of 2015) at your cost within 7 days from the date of the receipt of order as per the D O ltr no. The necessary Stamp Duty for the agreement shall be borne by you.

22. Termination:

- a. The contract will be reviewed in terms of the performance and services provided by you. If the performance is not found satisfactory, the contract can be terminated by MSETCL giving Fifteen Days notice to the agency.

- c. In case of Termination of Contract by the agency before expiry of the contract period, in that case the Security Deposit will be forfeited and charges payable to the agency will not be given
